- I/We hereby indemnify the Trust and each and every representative and/or official working under the authority of the Trust against any claims or demands whatsoever which may arise from or in respect of my/our competing in the event, including, but not limited to, any claims in respect of personal injury (whether wholly or partially covered by the provisions of the Accident Compensation Act or otherwise), any claims in respect of property owned by other competitors or spectators or other persons, or any local authority and I/WE AGREE AND CONFIRM that the Trust shall not be in any way liable for any such claims whether made by me/us or any person under my/our name or by my/our authority, or by any third party relating to any action of mine/ours.
- I/WE AGREE that this indemnity shall also apply to all persons who may participate in the event as a member of any boat owned or operated by me/us or in any way under my/our authority and I/ we further agree that if I/we are not the legal owner of the boat under my/our control that I/we have the legal owner’s permission to use the boat and are duly authorised to furnish any indemnities given on behalf of the owner of the boat.
